What determines the market value of your home?

- Current competition similar homes with regard to price, features, benefits, location, condition
- Level of demand...

It's taking an average of 4-6 qualified showings weekly to stimulate offers and get homes sold.

If you are not receiving this amount of activity within 7 days of coming on the market...your home is overpriced and you are missing the market.

If you are receiving this amount of activity but receive no offers within the first 14 days...your home is overpriced as agents are using your home to sell other homes that are competing with yours.

This is true regardless of if the property is \$300,000 or \$3,000,000!

THE PROCESS OF SELLING YOUR HOME

Here is a brief outline of our process to get homes sold:

-Bringing your home to market -Being on the market – market time -Offer and Negotiation -Escrow and Closing

PROCESS # 1 – Bringing your home to market:

- We clarify all timelines, goals, loan amounts, fees and net sheets.
- Walk through property to review condition and determine areas that need attention, tidying up and repair in order to enhance the property and ensure that it is in top showing condition inside and out.
- We review any items that convey with the property and determine parts of the home that need special attention if any.
- Schedule termite inspection to so we will know any additional costs that this may create.
- Coordinate contractors for the necessary repairs if needed.
- Once the property is "ready", professional photographs will be taken and uploaded on to the MLS including a slideshow. This will be attached to carefully written information about the property on the MLS listing. This will then be uploaded to multiple internet sites. 48 hours is needed for this process, prior to the property being actively on the market.
- A packet of disclosures will be provided to you and will need to be completed as soon as possible. This is information pertaining to the property that will be given to the buyer when we open escrow.
- A lockbox will then be put on the front door, which is connected to the computer. We are able to monitor exactly who has been in the property.
- A sign will be placed in the front yard.

YOUR HOME IS NOW ACTIVELY ON THE MARKET:

PROCESS # 2 – Being on the Market:

- Agents will call to schedule appointments.
- We will follow up with them once they have shown the property and give you feedback once a week. You will receive detailed email reports weekly so you know exactly what happened as a result of the showings.
- John will call each week to review all showing reports, review any changes in the market, answer any questions, and make any suggestions needed.
- John will be working 3-4 hours every morning generating further interest in the public and local agents by actively calling and speaking to them.

PROCESS # 3 – Offer and Negotiation:

You can be anywhere in the world, we manage this process:

- All documentation is done through an electronic signature process so it is convenient and easy for you.
- When we receive an offer, we will notify you and set and time to review and respond.
- We will be communicating with all other interested buyers putting them on notice of the offer to stimulate multiple offers.
- We will review the financial credibility of each buyer and where appropriate request that they are pre-approved through our extremely experienced and competent lender.
- With this offer process, we try and keep it as brief and short as possible to keep expectations and emotions positive.

PROCESS # 4 – Escrow and Closing:

- The escrow process is usually 30-45 days.
- Within the first **17** days the following will happen with the buyer:
- All buyer inspections will be done.
- Buyer will then possibly request repairs that need to be completed (or a credit is given at this time)
- The full approval on buyer's loan is given which includes the appraisal.
- The buyer reviews all the due diligence of the property. We co-ordinate all of this.

Day **18** the buyer physically signs a document removing all their contingencies to move forward with the sale. We strongly recommend that you wait until full removal to move forward with any moving plans committing fully.

We work closely with escrow as well as the lender and handle all the details to ensure the running of a smooth transaction through the close when you reach your goal.
