Payment Agreement

ACH automatic monthly debit

I (we) hereby authorize Keller Williams Realty, Inc. to initiate debit or credit corrections to the MARKET CENTER account already on file with the Finance Department of Keller Williams Realty International.

I acknowledge and agree that my coaching will begin the month indicated in the line below or the month this Agreement is received by MAPS (whichever is sooner) and will continue for twelve consecutive months thereafter. I authorize Keller Williams Realty, Inc. to collect payment as indicated above for coaching services in advance for each stated period on the 7th business day of the month. I further authorize Keller Williams Realty, Inc. to collect payment for the first month of this Agreement by initiating an ACH automatic debit upon receipt of this Agreement. If payment is not received within 30 days of due date, coaching calls will be suspended until payment is received. This authority remains in full force and effect throughout the term of this Agreement. At the termination this Agreement, this authority will continue on a month to month basis until Keller Williams Realty, Inc. receives written notification from me of my withdrawal from the Coaching Program in such time and manner as to provide Keller Williams Realty, Inc. a reasonable opportunity to act on the notice. You will have the above-prescribed number of calls, each call for duration of thirty minutes, unless a group call is assigned during Masterminds, Family Reunion, Mega Management weeks, or your coach's vacation. You are committing to a one-year term by signing this contract, a *covenant commitment*. A monthly hold fee of \$200 per month (\$400 for Mastery Combo) will apply for 90 days if you suspend coaching prior to the end of this agreement. A cancellation/termination fee of \$2,000 will be charged to the payment type on file for any contracts terminated prior to the end of the twelve month agreement. You will be charged for missed calls; it is your responsibility to notify your coach of any calls you will miss at least two days prior to the day of the call and to work with your coach to reschedule that call. You will be charged for a missed call without opportunity to make up that call if you fail to notify your coach within the time period set forth above. Keller Williams Realty, Inc. will not use or share the personally identifiable information provided herein in ways or for reasons unrelated to the ones herein without your prior written consent. The Client hereby acknowledges and agrees that calls may be recorded for training purposes only.
