You will have the above-prescribed number of calls, each call for duration of thirty minutes, unless a group call is assigned during Masterminds, Family Reunion, Mega Agent weeks, or your coach's vacation. You are committing to a one-year term by signing this contract, *a covenant commitment*. A monthly hold fee of \$50 per month will apply for 90 days if you suspend coaching prior to the end of this Agreement. A cancellation/termination fee of \$1,000 will be charged to the payment type on file for any contracts terminated prior to the end of this twelve month Agreement. You will be charged for missed calls; it is your responsibility to notify your coach of any calls you will miss at least two days prior to the day of the call and to work with your coach to reschedule that call. You will be charged for a missed call without opportunity to make up that call if you fail to notify your coach within the time period set forth above. Keller Williams Realty, Inc. will not use or share the personally identifiable information provided herein in ways or for reasons unrelated to the ones herein without your prior written consent. The Client hereby acknowledges and agrees that calls may be recorded for training purposes only.
