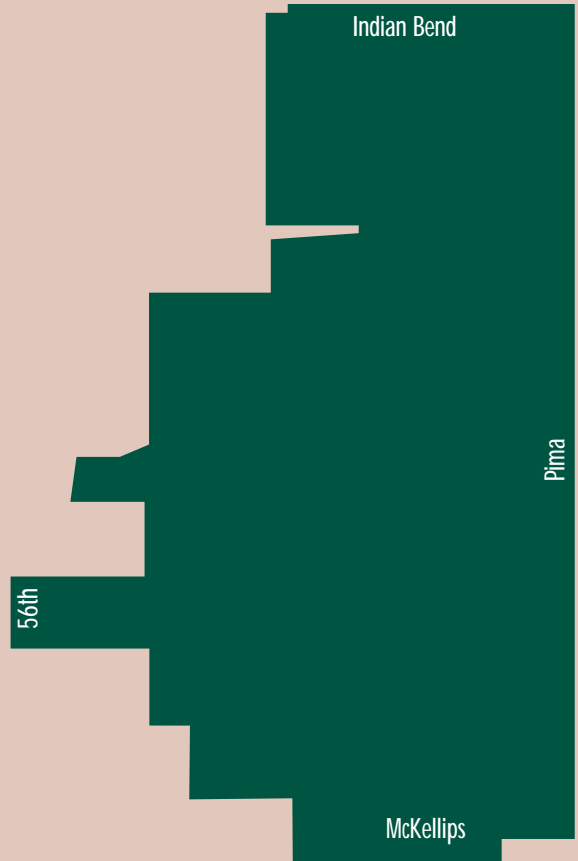

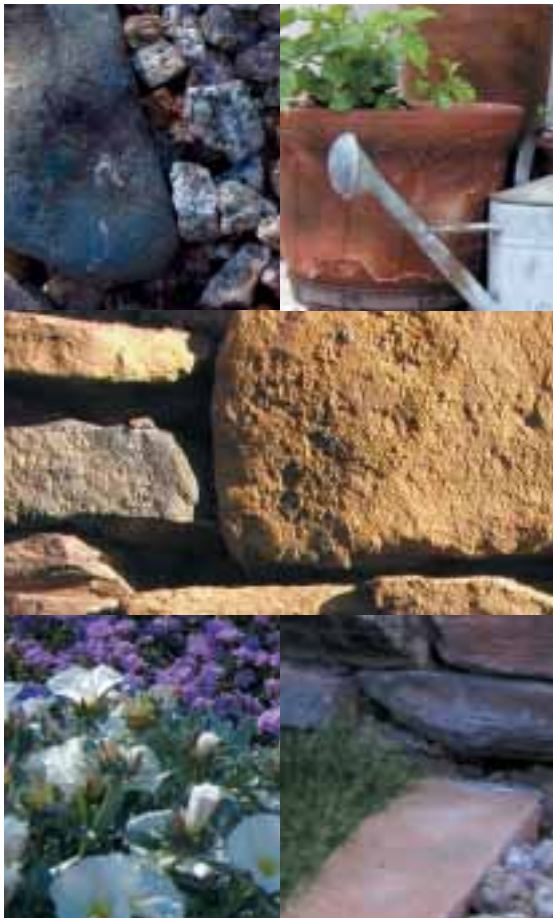

Improving Your Home

Your house is several decades mature and it might be time to make some improvements. Maybe you'd like to add more square footage, upgrade the electrical system or reduce your water usage? The following programs provide financial incentives, assistance, information and advice.



SOUTHERN AREA RESIDENTIAL FEE REDUCTION PROGRAM

Get your building permit and plan review fees waived up to \$2,000! Those who qualify should be single-family homes, owner-occupied or rental property.

PLUMBING REBATE PROGRAM

Low-flow showerheads and toilets will save you more than just water. By installing water saving fixtures, you may be eligible to get a rebate from the city. Your home or business must have been built before 1992. Eligible water-saving fixtures include showerheads that have a flow of 2.75 gallons per minute (gpm) or less and toilets rated at 1.6-gallons per flush (gpf).

LANDSCAPE ASSISTANCE PROGRAM

This program offers assistance to residential homeowners whose homes are at least 15 years old to beautify their front yards using desert-adapted plants in a low-maintenance landscape design. Home must be a single-family, owner-occupied residence.

ARIZONA BLUE STAKE

The rainbow of colors painted on the sidewalk at construction sites is not just for decoration. The colors identify the location of underground utility lines. If your improvement project requires digging, grading or excavating (planting a tree, installing a sprinkler system, laying underground pipe for a construction project, etc.), be sure to call the Arizona Blue Stake Center at least two days prior to beginning your project. It's the law and the service is free!

“ROCK THE HOUSE” PROGRAM

This citywide program helps qualified recipients meet Scottsdale property maintenance requirements. As part of the program, rock or gravel is supplied to low-income Scottsdale homeowners. The home must be a minimum of 15 years old and be owner-occupied.

TURF REMOVAL REBATE

Promote a healthy and attractive landscape, conserve water and save money! By removing turf and installing a low-water-use, drought-enduring landscape, qualifying Scottsdale single-family residential water customers can receive a one-time water bill credit of up to \$1500. This rebate is offered for the removal of turf from the landscape and the installation of city-approved landscaping and offers two landscape options. Properties that have received rebate credit in a previous landscape rebate program or have converted turf landscaping prior to August 5, 2005 are not eligible.

HOT WATER RECIRCULATION SYSTEM REBATE

To help reduce your indoor water usage, the city offers a one-time rebate of up to \$200 to qualifying Scottsdale single-family residential water customers who install a hot water recirculation system in their home. This water conservation system consists of pipes with a motor driven pump that recirculates water between a water heater and hot water faucets, eliminating the need to let water run until it gets hot.

TURF REMOVAL REBATE FOR COMMERCIAL/ RESIDENTIAL COMMON AREAS

Promote a healthy and attractive landscape, conserve water and save money! By removing turf and installing a low-water-use, drought-enduring landscape, qualifying nonresidential properties, multifamily residential communities and common areas of housing developments (within the Scottsdale water system) can receive a one-time water bill credit of up to \$3,000. This rebate is offered for the removal of turf from the landscape and the installation of city-approved landscaping. Properties that have received rebate credit in a previous landscape rebate program or have converted turf landscaping prior to August 5, 2005 are not eligible.

LANDSCAPE IRRIGATION CONTROLLER REBATE

Reduce and improve the efficiency of your outdoor water use and get money back! Qualifying Scottsdale water customers who purchase a new multi-program, permanently hardwired, electronically activated irrigation controller can qualify to receive a one-time water bill credit of up to \$250.

RESIDENT LANDFILL PROGRAM

Scottsdale Solid Waste residential collection customers...if you just can't wait until your next scheduled week of brush collection, there's a convenient way for you to discard your brush and bulk items. Through an agreement with the Salt River Pima-Maricopa Indian Community, Scottsdale single-family, Solid Waste customers may haul up to 2,000 pounds of refuse, brush or bulk items generated from their property to the Salt River Landfill at no charge. Usage guidelines must be followed to use this program free of charge.

BRUSH AND BULK COLLECTION/NINE-DAY RULE

The city's Solid Waste Management Division collects brush and bulk items once a month for paying residential refuse and recycling customers for items too large or numerous to fit in a regular refuse container. Depending on your area, you may be asked to place these items in your alley or in your front yard near the curb.

To help control debris in the streets and alleys, please follow the city's **Nine-Day Rule**: Place brush and bulk items out for collection no more than two weekends prior to the Monday of your scheduled pick-up.

ALLEY MAINTENANCE AND CONSTRUCTION DEBRIS

The city treats alleys for weeds and dust as part of its efforts to help maintain safety and meet state air quality standards. However, it is your responsibility as a home or business owner to maintain your alleyway overall. Please do not place cement, dirt or any other construction debris in the alleys or in any city refuse containers. If you have a contractor working on your home, it is your responsibility to keep construction debris out of the alley and ensure that it is disposed of properly.
