



The Homestead Exemption is available to legal residents of Georgia for their primary homes.

You are able to claim a partial exemption, which can amount to substantial property tax savings. Senior citizens may have additional exemptions available. You are entitled to the Homestead Exemption if you *owned and occupied your home by January 1*. Unless otherwise noted, the Homestead Exemption filing deadline is March 1st. Check with your county tax office because some deadlines may vary per county. Here is a list of some of the county offices.

What You Need in Order to File: A copy of the recorded warranty deed, Social Security numbers of all persons on the deed, the mortgage holder, and the amount of the mortgage. Some counties may require a copy of the closing statement and to see your driver's license.

NOTE: If you live in an incorporated city, please be sure to check with your city website to see if you are eligible for a homestead exemption on your city taxes as well.
